1. 健康保険料および介護保険料(40~64才の被保険者に適用)は、標準報酬月額に保険料率(健康保険98/1000, 介護保険14/1000)を乗じて算出します。負担割合は、事業主と被保険者折半です。

(被保険者負担の端数が50銭以下の場合には切り捨てし、50銭を超える場合は切り上げて1円単位とします。)

2. 健康保険料には、特定保険料(前期高齢者納付金・後期高齢者支援金等の拠出に要する保険料。保険料率47.52/1000相当)および、調整保険料(財政調整事業の拠出に要する保険料。保険料率1.30/1000相当)が含まれます。

3. 賞与支給時の健康保険料および介護保険料は、つぎの式により算出してください。

●健康保険料 標準賞与額(1,000円未満切り捨て)×98/1000(事業主と被保険者折半)

●介護保険料 標準賞与額(1,000円未満切り捨て)×14/1000(事業主と被保険者折半)

*標準賞与額 : 年度(4月1日から翌年3月31日)累計5,730,000円を上限とする。
